*PDI = Projected Digital Image. PDIs are simply ordinary digital images which are normally viewed on a monitor/iPad, etc. but for competition purposes are projected on to a screen.

ISSUING RESULTS

Results will normally be available in PhotoEntry by the end of the day after the competition.

Images and results for all competitions from 2013/2014 to 2019/2020 are available in the Members’ area of the website: TCC website → Members’ Area → Competitions (half-way down page) → Select a season → Select a competition → Click on large image to see individual image, score, title and photographer and use arrow keys to see the remaining images. Click the large X in the top-right to return to the season’s competition page.

Competition results from 2020 onwards can be viewed in PhotoEntry. See Appendix 3.

SECTION 1: GENERAL RULES

The rules can be accessed on the footer of the club website and you should be able to save your own copy of these rules. Open the rules, right-click anywhere in them and from the menu that appears, click "Save". You can save the rules as a .pdf file. If you have any problems, email philip.smithies@hotmail.co.uk who will send you a copy..

1. Competitions are only open to honorary and paid-up members of the club.
2. All images submitted for competitions must have been taken by you on film or with a digital camera i.e. they must originate from a photographic process and not from computer-generated graphics. Digital manipulation is accepted (unless otherwise stated) provided it's been done by you or, at the very least, under your direction. Images produced from materials copyrighted by persons other than you (e.g. the work of other photographers) are unacceptable: you must be able to claim the copyright for any image submitted. For example, if you use software to replace a sky then the new sky must be one of your images.
3. The final image must be a print or a digital file for projection (Projected Digital Image or PDI). Separate competitions are held for both image mediums (prints and PDIs). There are Competition Secretaries for both mediums.
4. Images may be colour, monochrome, infra-red or (for example) sepia unless otherwise stated in individual competition rules.
5. Except as specified below, images, or "near duplicates" of images, accepted for Tonbridge Camera Club competitions cannot be reused. For example:
 - Any image submitted in a particular medium in one competition may not subsequently be submitted into a different competition in a different medium e.g. an image entered in one competition as a print may not then be entered into another competition as a PDI.
 - Digitally manipulated versions (including colour to monochrome) of previously entered images are not allowed.
 - An image which is so similar to one previously submitted by the same member as to be almost indistinguishable from it will not be allowed.
 - In the interests of healthy competition, you should aim to follow the spirit of the rules and not submit similar images as different entries.
 - Please talk to the PhotoEntry Administrator(s) before the competition if you're unsure about the suitability of an image.
6. Any competition which in a given season attracts entries from three people or fewer will not be run.
7. Images submitted for internal competitions will be deemed to be available for use on the club website and/or PhotoEntry galleries and/or external competitions and/or the Annual Reports and/or internal AVs unless otherwise advised by email to the PhotoEntry Administrators. Any such restriction should be notified at the time that the image is first entered for an internal competition.
8. Closing dates for submission of entries are described below. They are normally on the Thursday before the competition.
9. On competition evenings, each entry is shown in turn, and the title is read out. The judge then makes his/her comments. A mark out of 20 is awarded and only then is the photographer's name revealed. For certain competitions, judges will additionally be asked to select first, second and third place entries. Images must not contain any reference to the photographer's name.
10. Whilst every care will be taken, the club can't accept any responsibility for loss or damage to material(s) entered for competitions or exhibitions.
11. To ensure smooth running of competitions, the Committee reserves the right to make minor changes to these rules at any time, but will ensure that the membership is advised.
12. Any image which does not conform to competition rules will be liable to disqualification.
13. Trophy winners are responsible for returning their *cleaned* trophies promptly when requested.
14. The Committee's decision will be final regarding all matters relating to the interpretation of these rules.
15. Entrants are deemed to have read and accepted the rules and conditions in this document.

SECTION 2: THE COMPETITIONS

The following competitions are held each season:

- There is an award for the 'Photographer of the Year'. See Section 6.11 for details.

Note: The closing date for ALL competitions is now a week before the competition itself.

The Annual Exhibition is quite separate from club competitions. See Section 7.

SECTION 3: IMAGE MEDIA RULES

3.1 GENERAL FOR BOTH PDIs and PRINTS **P D**

All images for both PDIs and Prints must be registered/submitted online to the PhotoEntry website at <https://compent.photoentry.uk/compent/>. You MUST read the separate “PhotoEntry User Guide” (Appendix 2) to understand fully how it works. When using PhotoEntry, please note that file names are limited by the software to FIFTY characters comprising alphanumeric, space, and the characters ,!'-%(). Note that many standard symbols are not allowed by the software and that very often permissible non-standard symbols cannot be the first character in a name. **If the name turns red when you enter it, you have used a symbol incorrectly.**

Before entering competitions, make sure you read every part of Appendix 1.

Before entering prints, make sure you also read Sections 3.3 and 3.4.

If you wish to enter competitions but haven't yet used PhotoEntry, you need to contact one of the PhotoEntry Administrators (currently Philip Smithies philip.smithies@hotmail.co.uk or Philip Easom preasom@btinternet.com) who will send you log-in details for PhotoEntry.

3.2 RULES FOR PDIs

Rules for PDIs are set out in Appendix 1. Note that we use a resolution of 1920 x 1200 to match the projector's resolution. PhotoEntry can resize images.

3.3 and 3.4 RULES FOR PRINTS **P**

NOTE: It is ESSENTIAL that you read very carefully the whole of this page as well as the “PhotoEntry User Guide”.

3.3 Preparing Prints

- a. Prints must be produced under your total control or direction. It is absolutely fine to have images commercially printed and to use commercial mounts and/or to have the print commercially mounted.
- b. Each print must be mounted or placed directly on the mount. The mount itself must be EITHER 50cm wide x 40cm high OR 40cm wide x 50cm high. Note: smaller mounts may be used for the Print Panel Competition and for the Small Print Competitions only.
- c. The print itself may be of any size that fits within or on the mount except for the “Small Print” Competition where the image must be no greater than 15cm x 15cm.
- d. Make sure that your entries will not cause damage to other entries e.g., don't use Velcro type strips on mounts, or leave exposed sticky tape.
- e. Ensure prints are stuck down properly.
- f. Please consider putting a backing on your prints. Without this, they tend to be floppy and spoil the viewing

3.4 Submitting Prints

- a. Upload a PDI version of your print images to PhotoEntry as if you're entering a PDI competition.
- b. The Print Secretaries will then decide on the running order and will allocate a number to each print. You will be advised of print numbers by email.
- c. On the evening of the competition, bring in your prints by 7.15 p.m. When you arrive at the meeting, write on the “post-it” note provided the number(s) allocated by the Print Secretary for the specific competition and place it on the FRONT of each print in the TOP LEFT-HAND CORNER. The Print Secretary will indicate where you should place your print on the stands to ensure they are in numerical order.
- d. The printed list of titles, with a column for marks, will be made available for the announcer. Images and marks will be available on the PhotoEntry website soon after the competition.
- e. You are responsible for bringing in your prints and taking them home on the day of the competition, or for arranging for another member to do so on your behalf. Prints will no longer be stored at the school or by the Print Secretaries.

SECTION 4: COMPETITION GROUPS



Currently, for all competitions whether Open (Section 5) or subject-specific (Section 6), there is only one group (Group A) to which everyone is allocated. Members compete on an equal basis.

However, if you are new to photography or regard yourself as inexperienced, for Open Competitions feel free to enter **(I) AFTER** the title when submitting your entries via PhotoEntry. This will ensure you receive feedback from the judges which is more suitable to your level of experience (for example containing more practical advice). Note that you **won't** receive any special allowance with the mark itself. This condition has been here for many years but is often overlooked.

SECTION 5: OPEN SUBJECT COMPETITIONS



- 1 A competition, consisting of **FOUR** rounds, is held for both image mediums.
- 2 You may enter as many or as few rounds as you choose. However, to be eligible for an Open Competition Award (see below) you must have submitted a minimum of seven images.
- 3 You may enter up to two images (either monochrome or colour) of **any** subject.
- 4 Each image is marked out of 20.
- 5 Trophy winners in each group, for each medium, are described below.

OPEN SUBJECT COMPETITION AWARDS

For both mediums, the following trophies and certificates are normally awarded:

- The Founder's Cup (Prints) / Newman Trophy (PDIs).
 - A trophy for the best new member (only available for members in their first year of eligibility).
 - A trophy for the most improved member (not available for members in their first year of entry and only awarded once to any individual).
 - In the above, members will be ranked in each medium in order of the aggregate score of the best SIX marks gained in all four of the rounds, with marks from the seventh highest entry being considered in the event of a tie. If there is still a tie, the eighth highest mark will be taken into account. If there is then still a tie, the awards will be shared
 - A certificate for the member with the highest aggregate score, and for those in second and third place..
- See also "Photographer of the Year Award".

SECTION 6: OTHER COMPETITIONS

6.1 – 6.4: RECORD, PORTRAIT, NATURAL HISTORY, ABSTRACTS and SCAPES COMPETITIONS – GENERAL POINTS:

- 1 For each of the Record, Portrait, Natural History, Abstracts and Scapes competitions, there are individual competitions for Prints and PDIs.
- 2 You may enter up to three images for each medium.
- 3 A trophy, to be held for one year, will be awarded to the member achieving the highest aggregate score in each of the competitions. In the event of a tie, the trophy will be shared.
- 4 Images already used in the Open Subject Competitions may not be entered in these competitions. However, individual entries from these competitions may afterwards be entered in Open Subject Competitions on one occasion only.

6.1 RECORD COMPETITIONS



“Record Photography” is the photography of inanimate objects including all man-made structures or artefacts including (but not restricted to) archaeological and architectural objects and details, historical artefacts, stained glass, statues, glassware, porcelain, ornaments, and mechanical devices. Subject matter not allowed includes Natural History and images which rely strongly on a pictorial element, such as landscapes and portraits.

The resulting image should be an accurate representation with detail visible in the full range of tones with an absence of digital noise and in as informative a manner as possible. It should be in sharp focus with no converging verticals or other distortion (for example lens distortion). It should accurately show shape, detail, form, colour and texture, so that it would help to recreate the subject in the event of it being damaged or stolen. Artistic interpretation is important provided it does not adversely affect the accurate recording of the subject in question. Appropriate lighting is essential to show details, colour and texture.

There are no restrictions to the techniques that you may use to record or process an image. However, the emphasis must be placed on accurately conveying information about the structure, function and/or appearance of the subject.

Individual file names should be factual – creative titles are unsuitable for this category. You can provide additional written information about each of your entries which will be read out as the image is shown. This information might include, for example, the subject's identity, location, size, age, construction materials, designer, builder, etc. as appropriate. Most people don't bother.

6.2 PORTRAIT COMPETITIONS



A portrait is a picture whose main content is the **human** (not animal) form. Images may consist of one or more individuals and they can have been taken in any setting e.g., candid/ “street” and formal/“studio”. There are no restrictions in the techniques that you may use.

6.3 NATURAL HISTORY COMPETITIONS **P D**

Only photographs of *living **organisms are allowed – but excluding domestic pets and “arranged” flowers. ***There are no restrictions on the photographic techniques that may be used subject to the ****general rules in Section 1 on page 2 above.

Images showing “behaviour” tend to score better than static images of animals such as vertebrates and invertebrates. The story telling value of an image will normally be weighted more than the pictorial quality.

The use of binomial Latin names of subjects is appreciated by some judges.

* i.e. not dead, stuffed or mounted.

** “organism” – Google “biological definition of organism” if you’re not absolutely sure what this means. Also, previously “feral” animals weren’t allowed but they will be now.

*** Previously, stitched and infra-red images weren’t allowed. Now they will be, as will pictures which have had an obviously artistic treatment applied.

****For example, no AI, no using parts of images which aren’t yours –read this section of the rules carefully if you’re not sure.

The previous rules, created a few years ago, were based on those for Nature and/or Natural History photography adopted by the International, National and Regional photographic governing bodies and the wider photographic community e.g., FIAP/PSA/RPS/PAGB/KCPA. However, their definitions change over time (sometimes significantly) so if you are thinking of entering such competitions, you should read their rules carefully as they are ALWAYS very strict about what is and what isn’t acceptable as well the amount and sort of photographic manipulation allowed. Ideally, make sure you still have the original RAW file.

6.4 SCAPES COMPETITIONS **P D**

A ‘scape’ image shows a vista including, but not restricted to, landscapes, cityscapes and townscapes, seascapes, waterscapes and skyscapes. Whilst these images may include trees, animals, people, *buildings (and other artefacts), these must not dominate the image and only form a very small part of it: the primary focus of the photography must be scenery in order to be considered a Scape. There are no restrictions in the techniques that you may use.

*An individual building does not qualify as a Scape whereas (for example) a row of buildings on a river front would be allowed. No one building should dominate an image.

6.5 ABSTRACTS COMPETITIONS **P D**

An abstract photograph is an image that moves away from literal, recognizable subjects and instead emphasizes shape, color, texture, light, pattern, or form as the primary content. The subject may be real, but its identity is obscured, transformed, or stripped of context so that the viewer responds to the visual experience rather than the object itself.

6.6 PANEL OF PRINTS COMPETITION **P**

1. This is for a panel of prints exhibiting a unifying theme, the interpretation of which is left to you.
2. You may enter only one panel which must be brought in on the night of the competition.
3. Please upload to PhotoEntry a jpeg of the “Display Plan” a week before before the competition at the very latest. The title should be that of the entire panel. Consult the PhotoEntry Coordinator if you’re not sure how to do this. If you prefer, one of us can prepare it for you. Alternatively, simply place the prints on the floor or table, photograph the whole thing (e.g. on a mobile) and upload it.
4. Panels may consist of up to six mounts. More than one print may be included in each mount (but no more than six individual images overall). The whole panel must be able to be displayed in two or three rows on the club's display stand.
5. The rules in section 3.1 above for Print images apply individual although mounts can be any size up to and including 50cm x 40cm. (Note: judges seem to prefer 50x40/40x50 mounts)
6. You may provide a short description of the panels and/or of individual prints. These would be read out by the Announcer at the appropriate points.
7. Marks out of 20 will be awarded. In the event of a tie, the member whose panel is judged the best will receive the Norman Denman Cup, to be held for one year. We also often ask for 2nd and 3rd places to be awarded.
8. Images previously entered in TCC competitions are ineligible. However, individual prints from the panel may afterwards be entered once in open competitions.



6.7 PDI SEQUENCE COMPETITION D

The rules below reflect the changes made to previous seasons' competition.

This is for a single PDI sequence (one sequence per member) containing between four and six images which displays a coherent theme (e.g. with a story-telling aspect) with the images to be projected one after the other.

1. Each image can be resized as described elsewhere.
2. There must be an overall title for the sequence and individual titles for each image.
3. *OPTIONAL* You may if you wish provide a short description for the sequence and/or short descriptions for each individual image which will be displayed or read out by the Announcer at the appropriate time. Send this information to the PDI Secretary when you enter your images. Most people don't bother.
4. The usual PhotoEntry rules for filenames apply i.e. TITLE only.
5. A linear montage (filename is the same as the overall sequence title), produced by either the competition organisers or by you, will be shown at the competition to act solely as an "aide-memoire" for the judge. This will be numbered "1" in the sequence. It will also be included as the final entry – no. 8 if you enter six images.

To summarise with an example for a sequence whose overall title is "EMOTION" and composed of SIX individual images:

EMOTION	(a linear montage prepared by EITHER the organisers OR by you with the sequence title)
RAGE	(your first image)
CALM	(your second image)
PEACE	(your third image)
HOPE	(your fourth image)
SADNESS	(your fifth image)
ELATION	(your seventh images)
EMOTION	(a linear montage prepared by EITHER the organisers OR by you with the sequence title)

- Images previously entered in TCC competitions are ineligible. However, individual images from the sequence may afterwards be entered once in open competitions.
- Marks out of 20 will be awarded. In the event of a tie, the member whose sequence is judged the best will receive a trophy, to be held for one year. We also often ask for 2nd and 3rd places to be awarded.
- Ideally, please submit entries TWO weeks before the date of competition in order to enable the linear montage of images to be prepared.

6.8 SMALL PRINT COMPETITION P

1. This is an open subject competition for prints with a maximum dimension of 15cm on the longest side. **Entries must be submitted via PhotoEntry with the deadline the week before the competition.**
2. A maximum of two prints per entrant are allowed.
3. Mounts themselves can be any size up to and including 50cm x 40cm.
4. Images previously entered in any TCC competition are ineligible.
5. Entries from this competition may afterwards be entered once in open competitions (but in each case in the image must be in or on the standard-sized mount).
6. **Marks will be awarded as well as first, second and third places (based on one image).** The member whose print is judged the best will receive the Small Print Trophy (to be held for one year).
7. **This competition always takes place on the same evening as another Competition and is judged immediately after the break.**
8. **The TITLE must be written on the FRONT of the print so it can easily be read by the judge and by members. Do NOT write anything on the back of the print and do NOT include your name. See picture above.**



6.9 PRINT OF THE YEAR COMPETITION P

You may enter TWO prints selected from your entries in any of the previous twelve months' print competitions, or from the current year's exhibition entries. If entry numbers are high, it may only be possible to use one print so you must indicate your first choice and your second choice. Entries will be awarded marks out of 20. In the event of a tie, the judge will be asked to select 3rd, 2nd and 1st places with the latter being awarded the Brother UK Shield (to be held for one year).

6.10 PDI OF THE YEAR COMPETITION D

You may enter TWO PDIs selected from your entries in any of the previous twelve months' PDI competitions or from the current year's exhibition entries. If entry numbers are high, it may only be possible to use one PDI so you must indicate your first choice and your second choice. Entries will be awarded marks out of 20. In the event of a tie, the judge will be asked to select 3rd, 2nd and 1st places with the latter being awarded a trophy (to be held for one year).

NOTE: for both PDI and Print of the Year Competitions, there must be no "media-switching" i.e. an image which was judged as a PDI cannot then be entered as a print and vice-versa. You can "tweak" images if necessary e.g. as a result of judges' comments.

6.11 PHOTOGRAPHER OF THE YEAR AWARD **P D**

This is awarded to the person who attains the highest aggregate mark based on the scoring system outlined in the following sentences: After each competition including AV, PDI Sequence, Print Panel, Small Print, Record, Portrait, Scapes, Natural History + each round of the Open Print and PDI Competitions, each mark of 20, 19 and 18 (*) will count towards the award. The person with the highest total score will receive the club's most prestigious award.

Everyone is automatically eligible. It is unlikely that anyone will enter all rounds – and it certainly isn't necessary.

**In competitions where positions rather than marks are awarded, 1st place will receive 20 marks, 2nd place will receive 19 marks and 3rd place will receive 18 marks.*

6.12 AUDIENCE VOTE **P D AV**

For non-open competitions, we are introducing an "Audience Vote". When you arrive, you will be given a piece of paper in which you name your first, second and third choices for the competitions concerned. You should do this ideally before the judge's comments but otherwise before the judge's scores. The results will be announced at Presentation Evening and the photographers of the winning image(s) will be presented with a certificate.

7 ANNUAL EXHIBITION **P D**

This is an open exhibition and NOT a competition. The dates for the submission of entries have not yet been confirmed but the exhibition itself will take place at the Royal Tunbridge Wells Arts Society building in the Pantiles on Sat/Sun 14th/15th and 21st/22nd November 2026.

Conditions of Entry

1. The Exhibition is quite independent of club competitions.
2. Any image may be submitted provided it hasn't been accepted in a previous exhibition.
3. All TCC members may enter. You are guaranteed to have at least one image accepted in each medium.
4. You may submit up to four prints and/or six PDIs. It is your responsibility to supply frames for prints which have been accepted.
5. Prints must be mounted – and **NOT** placed directly on the surface of the mounting board. The mounts must be EITHER 50cm wide x 40cm high OR 40cm wide x 50cm high.
6. The three PDIs should be sent to philip.smithies@hotmail.co.uk at a resolution of at least 1920 x 1080 with the file name: TITLE by Author (TITLE = UPPER CASE; by = lower case; Author = Mixed Case) e.g. WALMER CASTLE by Freda Bloggs. This is how the title will appear when shown the TV. **Jpegs or tiffs are acceptable and there is no need to resize.**
7. Duplicates or near duplicates (as defined in Section 1.6) of images previously accepted in a Tonbridge Camera Club Exhibition are not eligible.
8. Entries must be prepared as described above and in the Appendices. PhotoEntry is not used.
9. The arrangements for submitting entries will be issued nearer the time.
10. The Club cannot accept responsibility for damage to members' work.

IMPORTANT: MAKE A COPY OF THE IMAGE YOU INTEND TO USE. When you have resized, saved and closed the image, the process cannot be reversed. Always work on a copy of the image.

SUBMITTING IMAGES

On-line using PhotoEntry. See “PhotoEntry User Guide” which has been modified since it was first issued (Appendix 2).

EXIF DATA

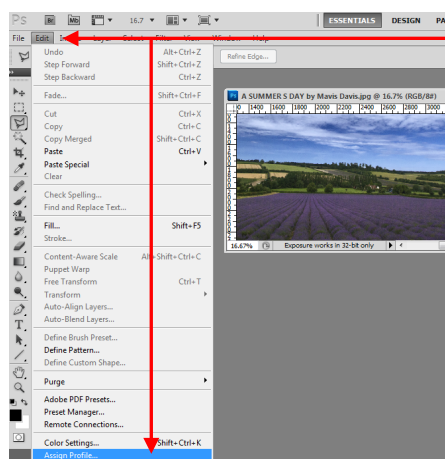
PhotoEntry does not remove EXIF data except when it creates thumbnails and Viewing Galleries. As it is too time-consuming for the PDI Secretary to remove it, you may therefore prefer to remove it yourself before you upload your images although the overwhelming majority of entrants don’t bother and there is no necessity to do so.

Once EXIF data is removed, it cannot be restored.

The club website automatically removes EXIF data.

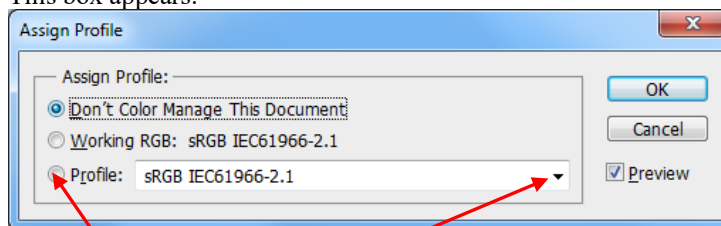
SETTING THE COLOUR SPACE (optional)

sRGB (not Adobe RGB) is the *preferred* setting as this is what *external* PDI competitions often insist on. If your entry were to be selected for an external competition, the External PDI secretaries may well ask you to ensure that sRGB is chosen. That said, the club projector is set up in such a way so that whatever colour space you use, the image will be projected to show it at its best.



To specify/check the Colour Space in Photoshop, select Edit→Assign Profile.

This box appears:



Click “Profile” and choose “sRGB” from the drop-down list.

Note: When this box opens, you may well find that sRGB is already selected. If this is the case, simply click “Cancel”.

Note: PhotoEntry will “warn” you if the Colour Space is not sRGB. Unfortunately, it cannot be configured to remove this warning. It is therefore suggested that you simply ignore it.

NAMING IMAGES

- The title must be in upper-case although PhotoEntry automatically corrects any in lower-case or mixed-case.
- The title must NOT contain the word “by”.
- The title must NOT include your name.
- PhotoEntry will reject any titles which contain characters forbidden in Windows filenames (i.e. \ / : * ? ” < > |).
- Don’t add (for example) 1 of 2 or 2 of 2 to the title. You can easily order your images in PhotoEntry
- Only JPEGs are accepted and therefore the extension must be .jpg/.jpeg or .JPG/.JPEG. Consult your computer’s “Help” section if you can’t see the extension in any of your folders (enter “view extension” in the search box).

RESIZING IMAGES

Images are projected at a size of 1920 pixels wide by 1200 pixels high (in a 16:10 ratio) and **ideally** should be resized accordingly. The width must not exceed 1920 pixels and the height must not exceed 1200 pixels. The projection software will automatically place a black background around any image with a ratio other than 16:10 so **please do NOT add black backgrounds.**

However, with the introduction of PhotoEntry, it is no longer compulsory to resize images (although we recommend it) as the software will do it for you. **SEE APPENDIX 4 FOR FOUR WAYS OF RESIZING IMAGES**

ADDING A BORDER (STROKE) (optional)

If you wish to add a border (stroke, as Photoshop calls it), consult your software guides or go on-line for further information. A border may be added before or after resizing and there are a variety of ways of doing this. Depending on the method you choose, you would need to ensure that you haven't removed a critical part of the outside of the image or increased the dimensions of the image beyond the acceptable size.

BACKGROUND COLOUR

The overwhelming majority of people leave the background colour as black for those images which are not exactly 1920 x 1200 pixels.

Please DON'T add black backgrounds by extending the canvas size: there is no need to do so and it subsequently involves extra work for the competition secretaries, exhibition organisers and webmasters.

SPELL-CHECK

Before submitting your image, consider using a spell-check on the title to eliminate typos. You can see for yourself in the competition results on the website numerous examples of spelling mistakes – although we do try to correct them – and judges often draw attention to them.

Some words seem to be regularly spelt wrong e.g. BODIAM (not Bodium) and ALTAR (as in a church – not ALTER). Perhaps the most memorable example of bad spelling was “The Chaple of the Royle Navel Collage”.

JUDGING

APPENDIX 2 – PHOTOENTRY USER GUIDE

When you email the PhotoEntry Administrators (currently philip.smithies@hotmail.co.uk, preasom@btinternet.com and psherren@zoho.com) that you wish to enter competitions, your name and email address will be entered into PhotoEntry and you will receive an automatically generated standard email (it may possibly go to your junk mail so check there).

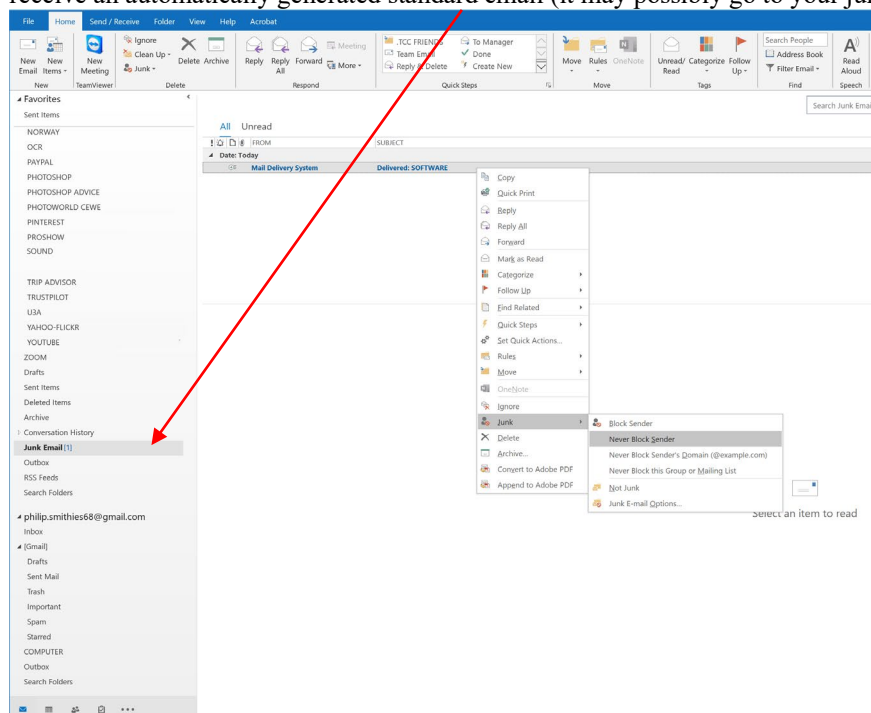
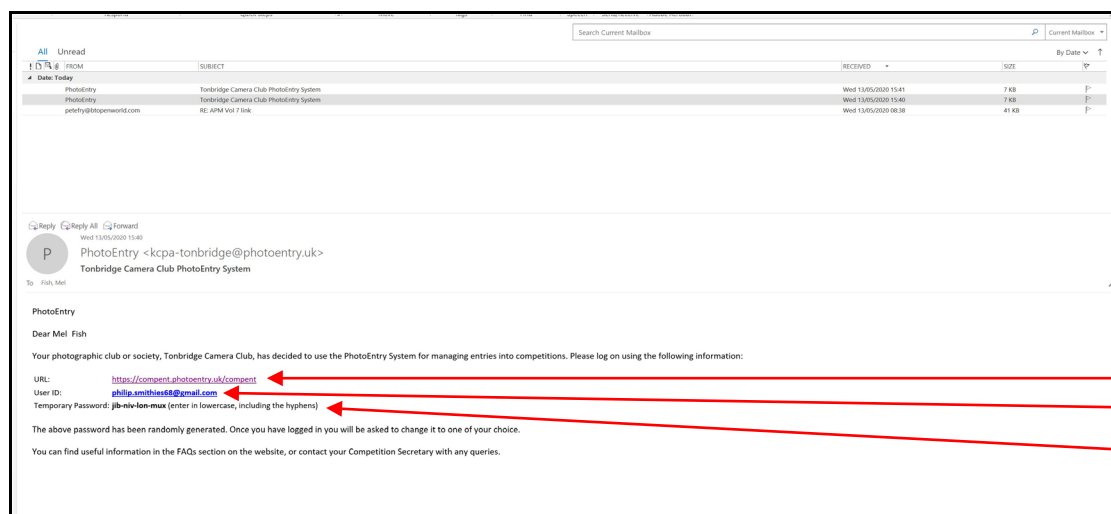

To stop important messages going to junk:

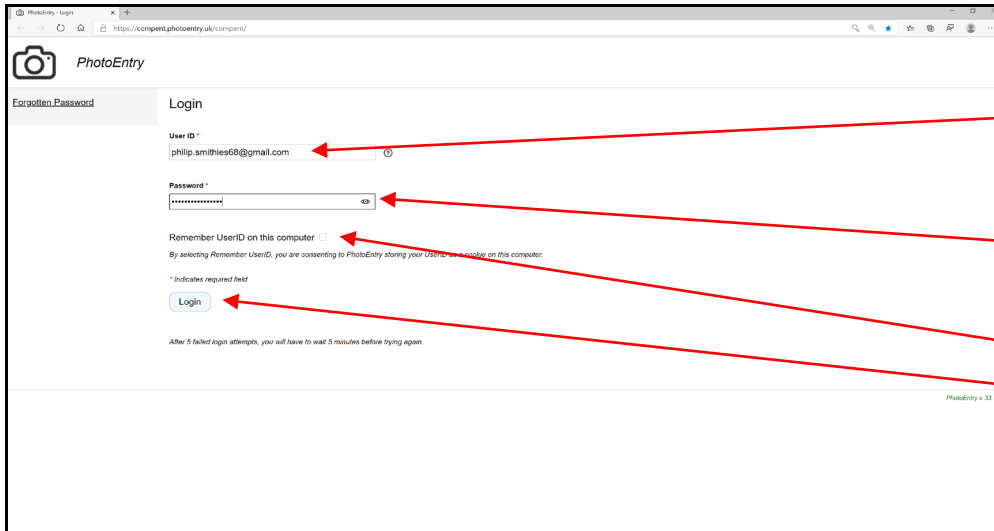
- 1 right-click on the message
- 2 in the menu that appears, left-click “Junk” and select the most appropriate option (usually “Not Junk” or “Never block sender”).
- 3 This usually works for future occasions – but not always. Periodically check your junk emails.
- 4 Move the email to the normal in-box.

NOTE: Fig 00 is a Microsoft Outlook screenshot. Your screenshot may not look the same and may have different options for handling junk emails.



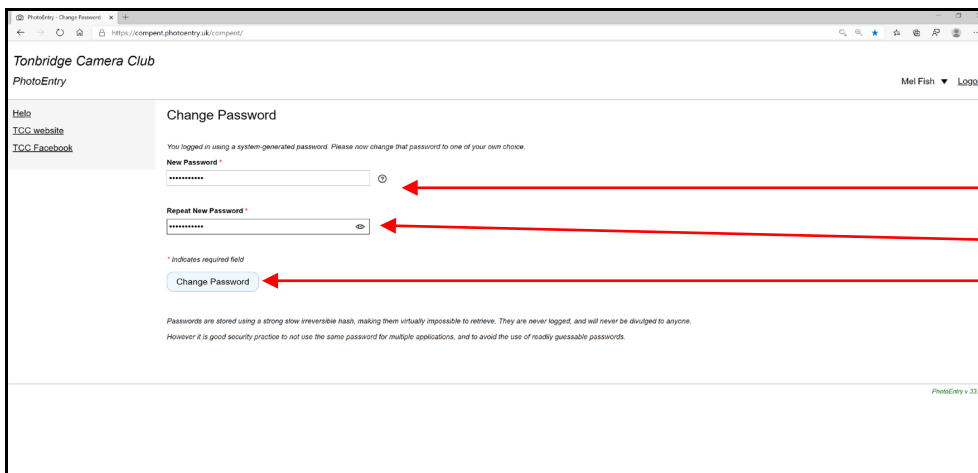

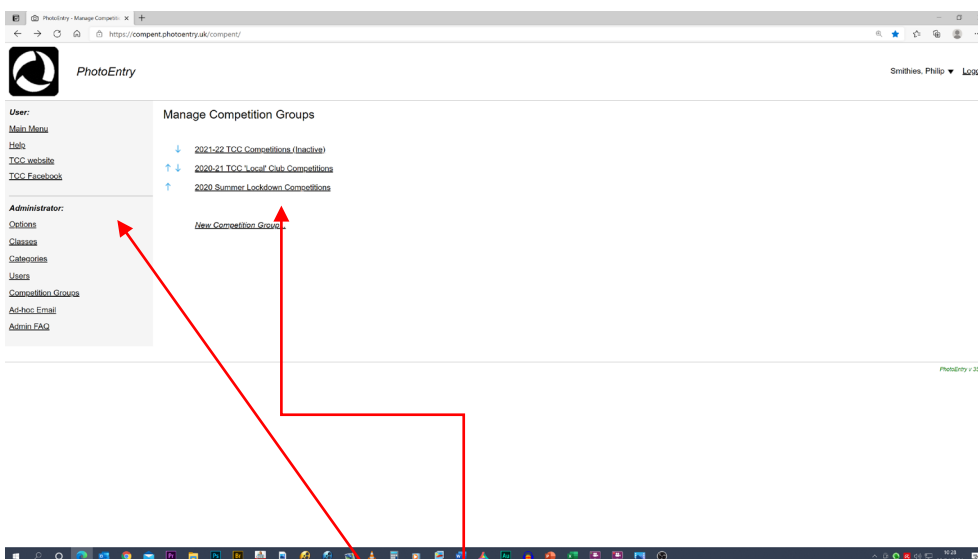

NOTE: RESIZING IMAGES

It is no longer compulsory to resize your images as PhotoEntry software will do it for you although we suggest you should consider it. Read Appendix 4A below for more information based on that given in PhotoEntry’s “Help” section.

Every internal competition will be configured with the projector’s “Target Dimensions” of 1920 x 1200.

If you want to resize your images but don’t have any photo-editing software, read Appendices 4B (A simple and free way to resize images online without using software) and/or 4C (A simple and free way to resize images using Microsoft’s “Photos” App). If you have Photoshop, read Appendices 4D and 4E.

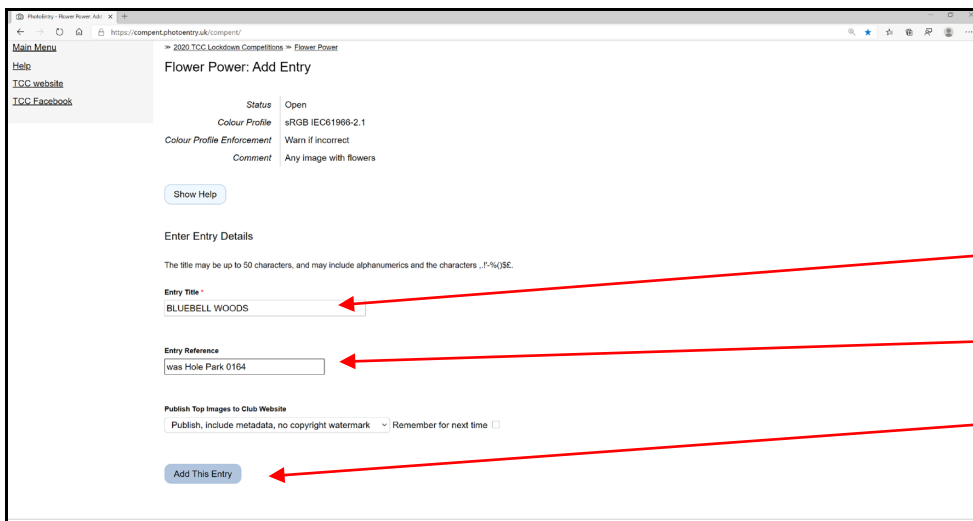
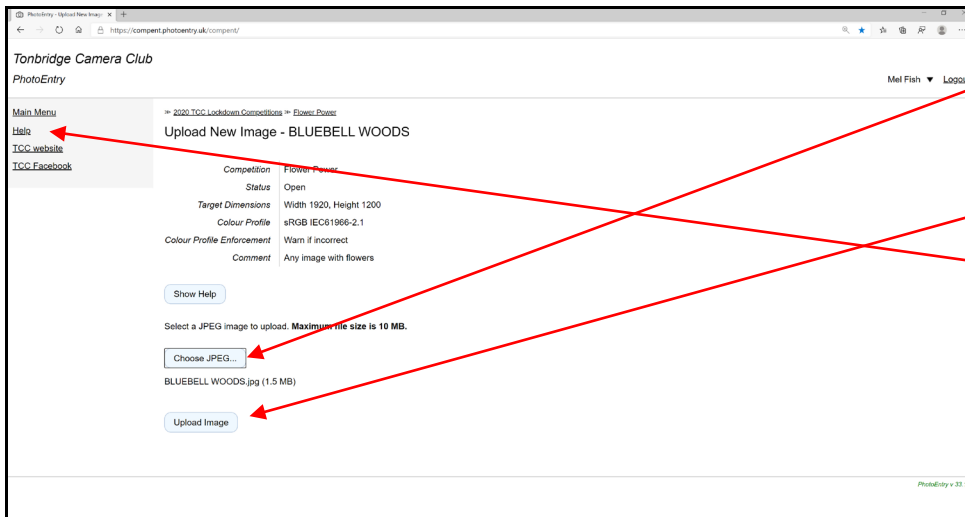

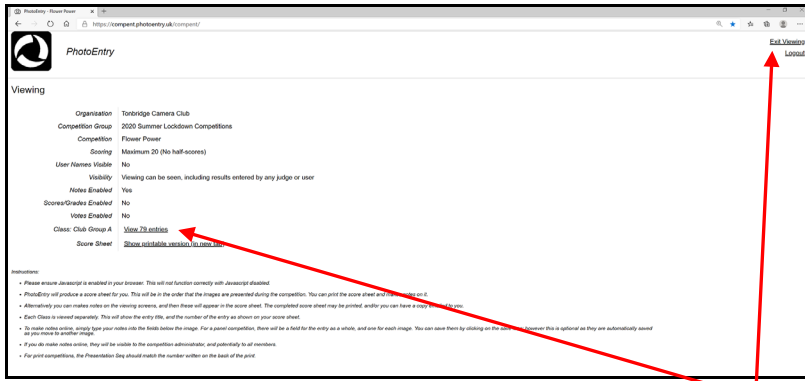
APPENDIX 3: VIEWING COMPETITION RESULTS VIEWING EVERYONE'S ENTRIES AND MARKS FOR A JUDGED COMPETITION

To view the results and image gallery of a single competition:

- 1 Log-in to PhotoEntry
- 2 Click on the relevant **judged** competition



4 Between the data list and the thumbnails of your individual entries you'll see “View Entries for All Users”. Click on this.



- 5 By the words "Class: Club Group A", click on "View xxx entries"
- 6 The images will appear in numerical order from 20 downwards. The marks and authors' names are in a box underneath labelled "Entry Notes" and/or by the title.
- 7 Use the arrow keys to navigate through the gallery.
- 8 Click on the image to view it full-screen. Click on the image again to return to the normal screen.
- 9 When you've finished, click "Exit Viewing" on the top right.

VIEWING ALL YOUR INDIVIDUAL ENTRIES FOR A SEASON

To see ALL your individual entries and marks from an entire season, click on (for example) "2022-23 TCC Competitions" and then 'Show your entries in this Group'. Clicking on an individual image enables you see it full-screen.

APPENDIX 4A: DO I NEED TO RESIZE IMAGES?

In two words: NOT USUALLY ... but read the rest of this page

Always check the required dimensions shown on the image upload screen. They will almost invariably be 1920 x 1200.

- DiCentra, the projection software we often use, prefers images to be sized correctly, and has been known to display images in a less than desirable way if they are not.
- To be **absolutely** sure that your image is displayed in the best form, you should resize the image before uploading it (as described in Appendices 4B to 4E). However, PhotoEntry will do an excellent job of resizing it (retaining the same aspect ratio) for you, if necessary, although the best results will only be obtained if the uploaded image is substantially **larger** than the required dimensions. For example, if 1920 x 1200 target dimensions are specified, submitting a 1940 x 1237 image will not yield a good result, but submitting (for example) a 3800 x 2400 image will be quite acceptable. Clicking on the thumbnail will show the resized image for you to check. Downsizing always gives better results than upscaling.
- A warning will be triggered if the target dimensions are not met. Depending on how the competition rules are configured, the software may reject your image and tell you to resubmit.
- A very common mistake is to resize for the long side. The size requirements specify a maximum width of 1920 and a maximum height of 1200. This is NOT the same as specifying a height of 1920 and a width of 1200.
- A "LANDSCAPE" format is one in which the width is greater than the height; a "PORTRAIT" format is one in which the height is greater than the width. (1920 x 1200 is also, of course, a landscape format).
- **If the image is 10MB or larger, and/or more than 8300 pixels wide x 5600 pixels high, PhotoEntry will reject it. In these cases, you might need to save it at a lower quality (e.g. 9 or 10 rather than 12) and/or resize it.**
- If you're happy to let PhotoEntry resize your images, don't bother reading the rest of this document.

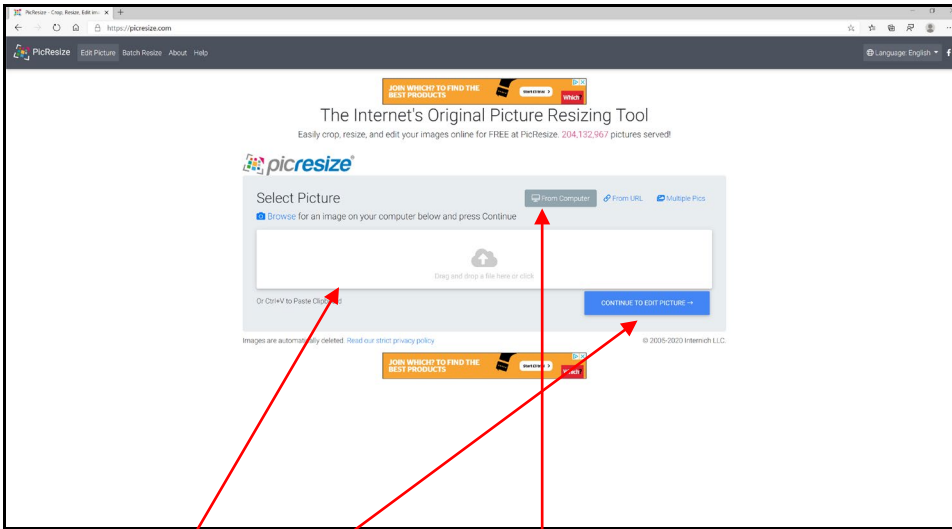

 Drag an image here (or use the “From Computer” route) – this can be quite slow, depending on the size of the image. Then click “Continue to edit picture”

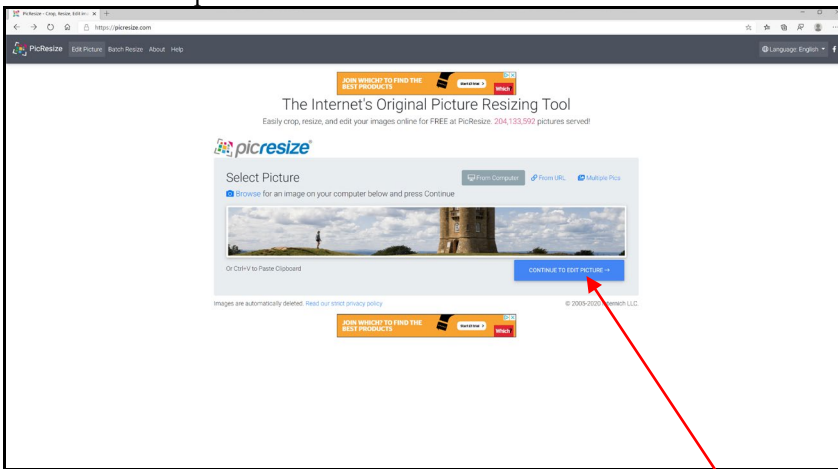

 Don't worry that only part of the image is visible. Click “Continue to edit picture.”

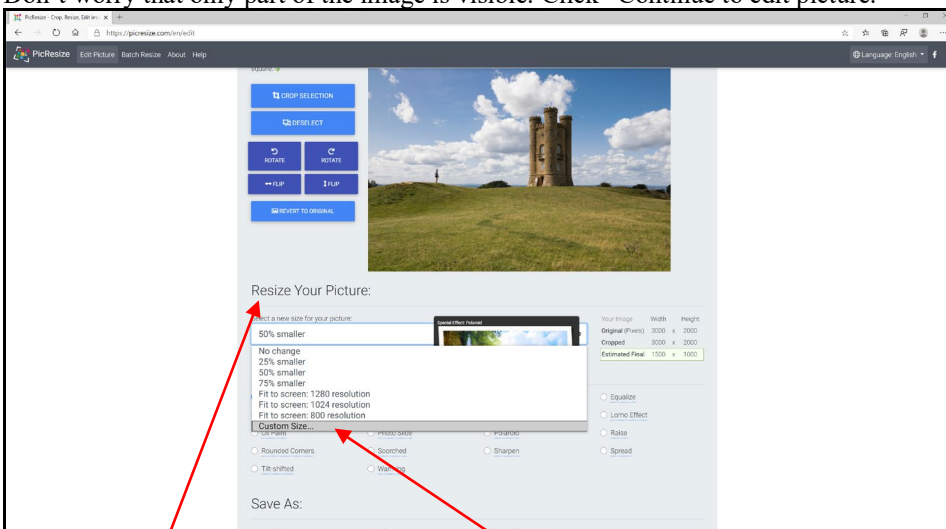

 Click on “Resize Your Picture” and select “Custom Size” from the drop-down list

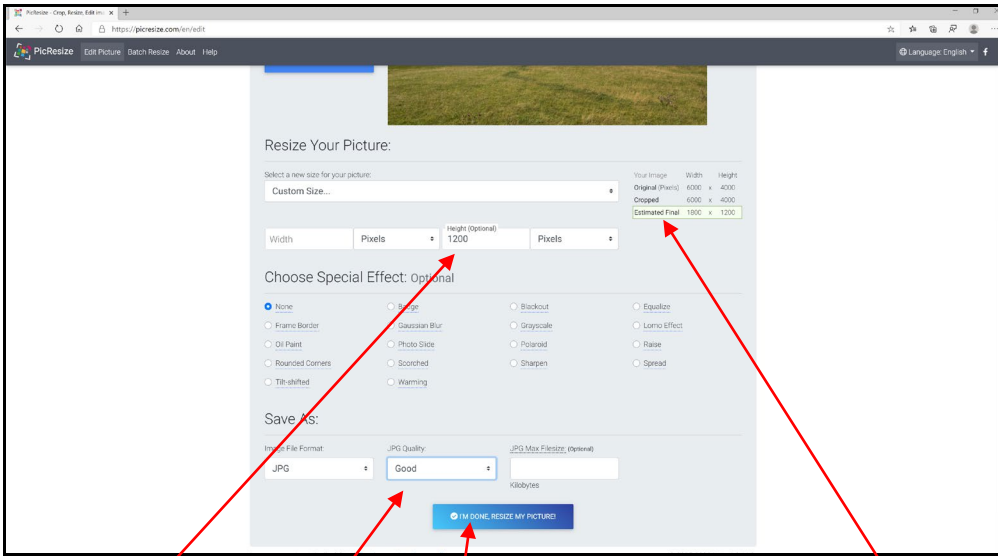

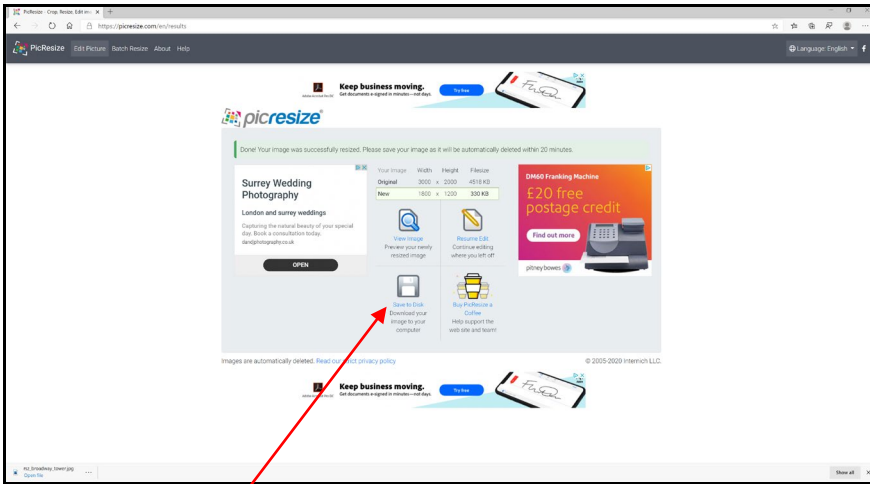

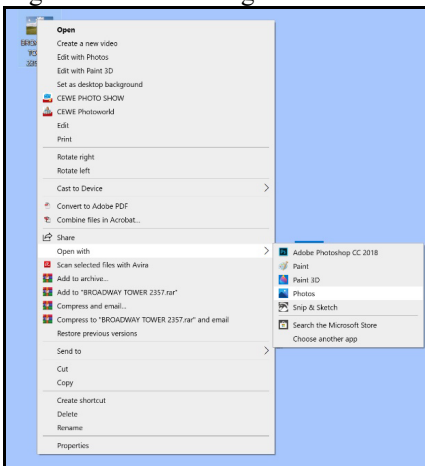

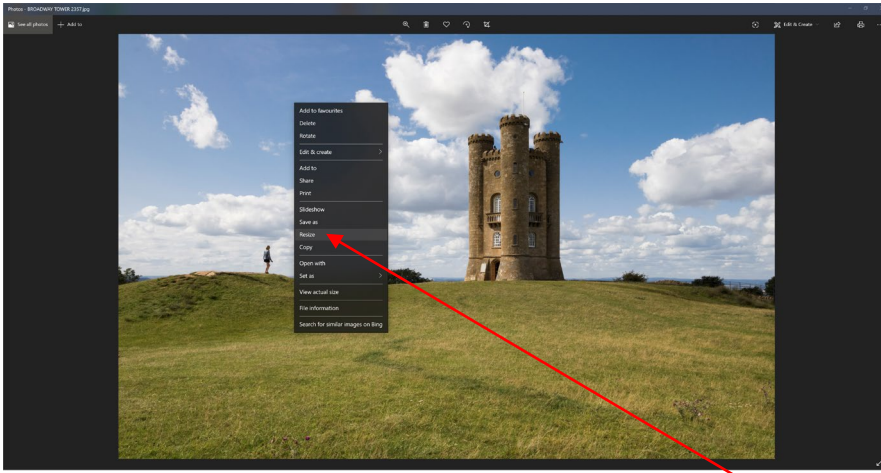

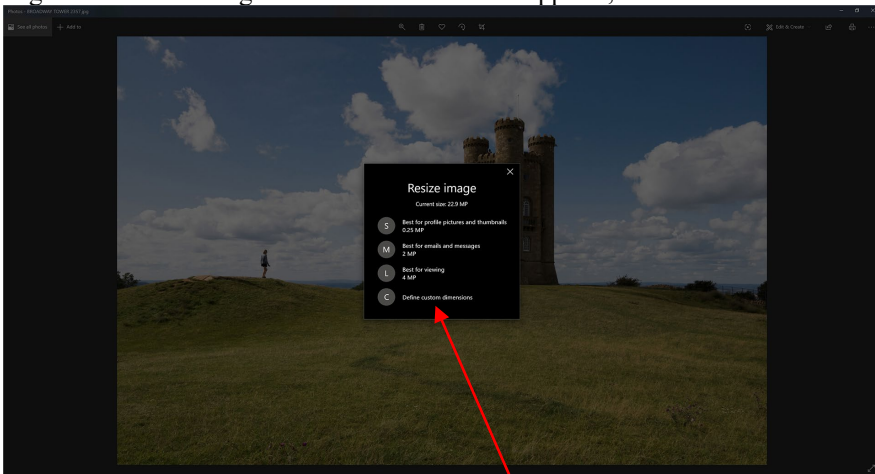

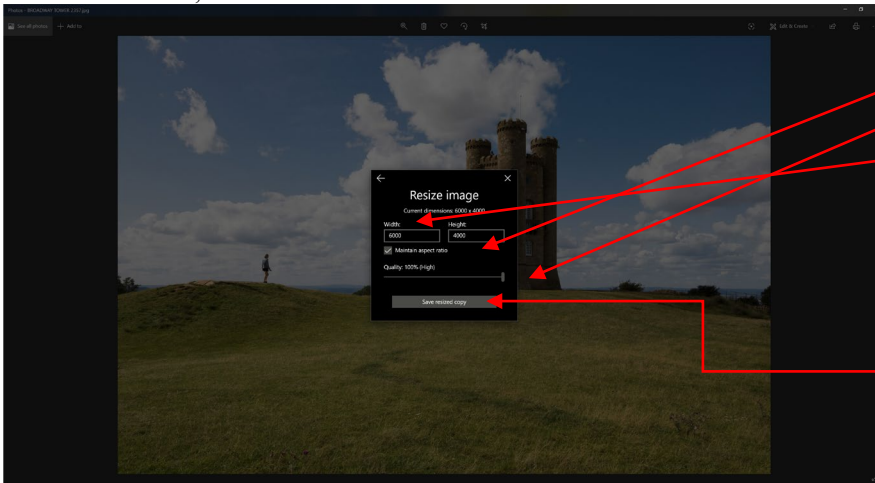

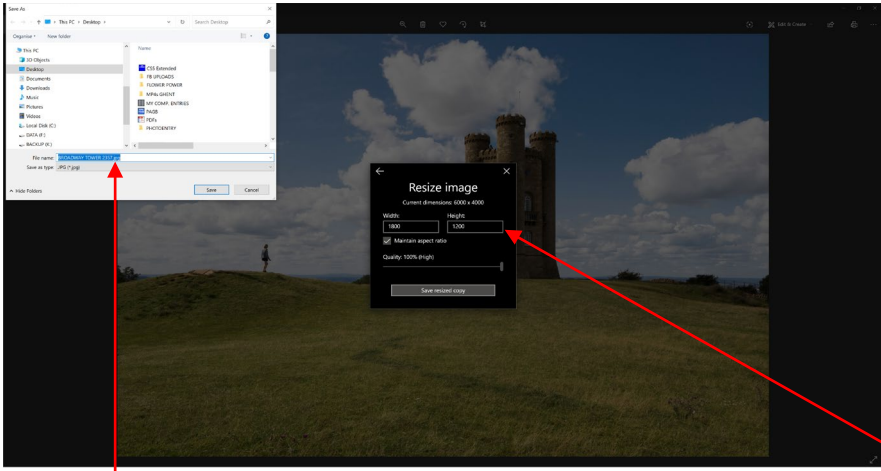

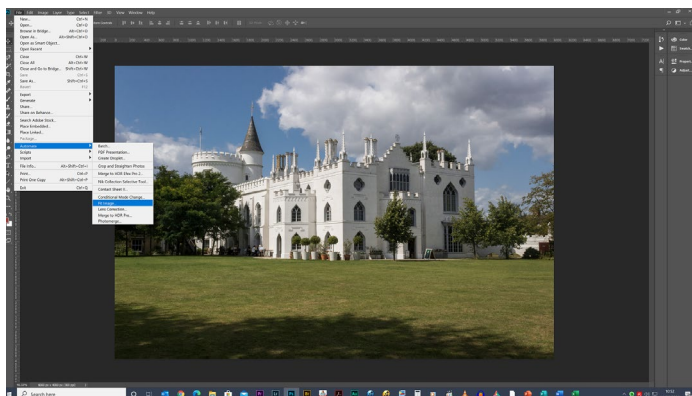

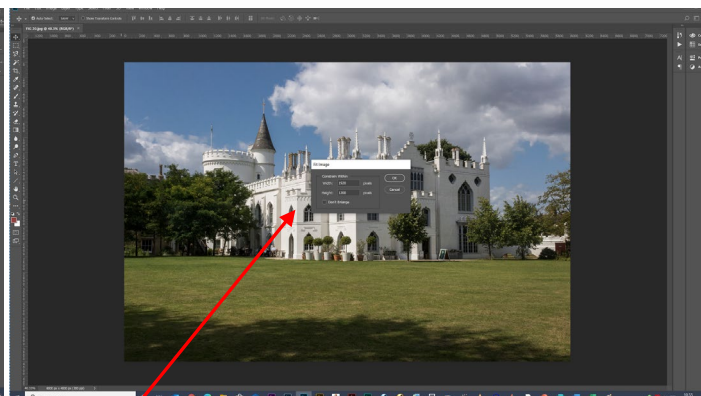

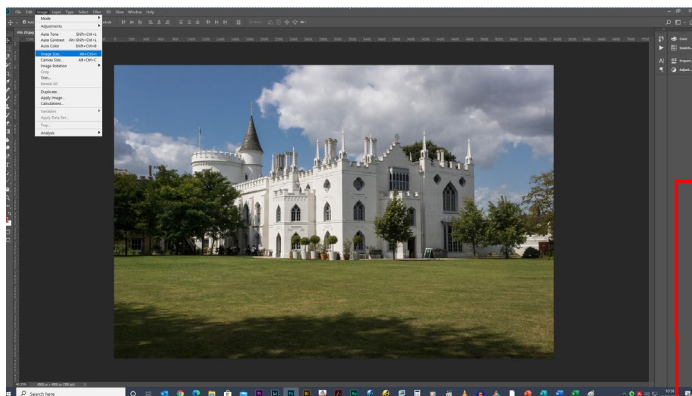

Image → Image size.

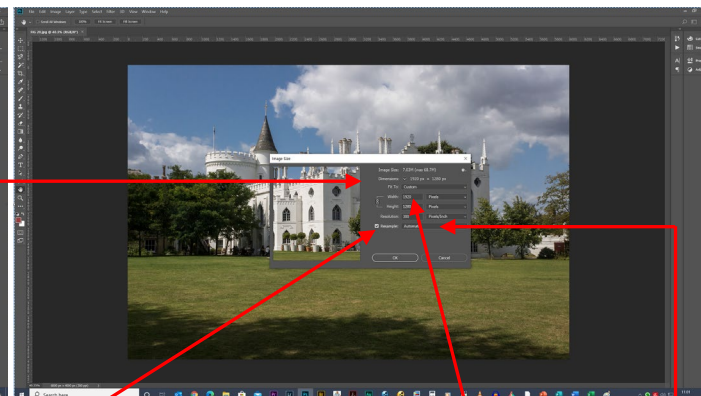

1. Ensure “pixels” is selected from the “Dimensions” drop-down box.
2. If the image is in “Landscape” format, enter “1920” in Width box. The “Height” will then adjust automatically. If the height adjusts to a value greater than 1200, then go straight to point 3.
3. If the image is in square or “Portrait” format, enter “1200” in Height box. The “Width” will then adjust automatically. If the width adjusts to a value greater than 1920, then go back to point 2.

6. However, you may prefer to carry out some research to determine if one of the other options in the drop-down list would be more suitable for you.
